Last year's House proposal created an airline dominated air traffic control corporation funded in part by user fees on charter operators. General aviation industry stakeholders will share perspectives on the corporatization proposal, their respective legislative "asks," and how general aviation can move forward together towards FAA legislation that benefits all users.
