

Award Nomination Criteria

Each year, NATA presents awards to exceptional individuals and organizations that have helped to improve the general aviation community. The 2015 Awards will be presented during the NATA Industry Excellence Awards presentation lunch June 10, 2016.

Please review the below criteria for each award and submit a completed nomination form. Only NATA members may submit nominations.

Airport Executive Partnership

- ➤ Awarded to an airport manager for outstanding efforts to foster relationships between aviation businesses and airport operators.
- ➤ Nominee must illustrate leadership in the "partnership" between airport operators and airport tenants.

ATP/NATA General Aviation Service Technician Award

➤ Awarded for outstanding performance by a licensed airframe and power plant mechanic or radio repairman who has practiced the craft for a period of 20 or more years.

Excellence in Pilot Training

➤ Awarded to an individual or organization for outstanding contributions in safety, professionalism, leadership and excellence in the field of pilot training.

FAA Service Excellence

- ➤ Awarded to the FAA field office demonstrating the highest level of professionalism to aviation businesses.
- ➤ Nominees must be FAA facilities responsible for operating and certification safety oversight and will be judged on effective communication, regulatory compliance advising, regulation application and timeliness in administering FAA responsibilities.

Safety 1st Certified Line Service Professional Award

- ➤ Awarded to an individual for the positive impact he or she had on safety, service and business success.
- ➤ Nominee must be currently Safety 1st PLST or Supervisor certified.
- ➤ Nominating company should be prepared to support the nominee's attendance at the NATA Industry Awards Lunch presentation.
