Patron Membership - for individuals who are not eligible to be Regular, Affiliate or Associate Members through their company. This category is also available to charitable organizations. Patron members receive access to NATA's website and email communications, and are eligible to attend committee meetings as a guest.

**Student Member** (Dues \$25)

Student Membership - for active students. A copy of a valid student ID is required at the time of application. Student members receive access to NATA's website and email communications, and are eligible to attend committee meetings as a guest.
