

Notes on State Issued DL/ID cards

REAL IDs have stars. The stars can vary by state and may be inside a symbol of the state or other important state symbol (e.g., a bear for California).

Non-compliant cards may have the words "Not valid for Federal Use" or words to that effect. Non-compliant DL/IDs do NOT have a star. DL/IDs that were issued before a state became REAL ID certified are called legacy cards. They do not have a star and may not indicate "Not for Federal Use". They are not REAL ID compliant and not acceptable for identity verification.

Enhanced Driver's licenses (EDLs) include the word ENHANCED, have a chip and the symbol of the U.S. Flag and a machine-readable zone (MRZ). EDLs are REAL ID compliant. States offering EDLs: Michigan, Minnesota, New York, Vermont, Washington.

Acceptable Forms of ID on tsa.gov

Adult passengers 18 and older must show valid identification at the airport checkpoint in order to travel.

- REAL ID compliant driver's licenses or other state photo identity cards issued by Department of Motor Vehicles (or equivalent). A temporary driver's license is not an acceptable form of identification.
- State-issued Enhanced Driver's License
- U.S. passport
- U.S. passport card
- DHS trusted traveler cards (Global Entry, NEXUS, SENTRI, FAST)
- U.S. Department of Defense ID, including IDs issued to dependents
- Permanent resident card
- Border crossing card
- An acceptable photo ID issued by a <u>federally recognized</u> Tribal Nation/Indian Tribe, including Enhanced Tribal Cards (ETCs).
- HSPD-12 PIV card
- Foreign government-issued passport
- Canadian provincial driver's license or Indian and Northern Affairs Canada card
- Transportation Worker Identification Credential
- U.S. Citizenship and Immigration Services Employment Authorization Card (I-766)

- U.S. Merchant Mariner Credential
- Veteran Health Identification Card (VHIC)

Not listed on tsa.gov but still acceptable: ID issued to Members of Congress (senators, representatives) and their spouses, Prison IDs (state or Federal with name, photo, DOB), United Nations Laissez-Passer, Aircraft Operator Photo ID (at any US Airport), U.S. Department of State IDs, DHS Refugee Travel Document (I-571), Department of Homeland Security (DHS) Re-enter the United States (I-327), Airport or Aircraft issued SIDA ID (valid at airport where issued)

Acceptable only for performing an Official Duty (not acceptable for personal travel): FAA Aviation Safety Inspector Credential (FAA Form 110A), FAA HazMat Aviation Safety Inspector Credential (FAA Form 1600-24-1), Airport Sterile Area ID (valid at airport where issued),

No longer acceptable for travel at TDC as of 4/28/2025:

Federal Judge, Registered Traveler Card, Canadian Province or Territory ID, U.S. Government Agency Credential + Second Form of ID, U.S. Department of State issued Diplomatic Tax Exemption Cards

Digital IDs

Google ID Pass is accepted at TSA TDC.

For mDLs issued by a state DMV:

- "REAL ID" indicator on CAT No additional ID verification may be needed
- "Not REAL ID" indicator on CAT Ask for another physical and acceptable form of ID, unless it is CLEAR or Google ID Pass.
- List of eligible digital IDs (mDLs) on tsa.gov may change May 7.
